Executive Director's Foreword: Looking back at 2023

2023 saw APCASO significantly leap forward on work towards our 2021-2030 Strategic Plan Focus of Change areas: Improving Health Outcomes; Community, Rights and Gender (CRG); Strategic and Sustainable Health and Rights Financing; Community Systems Strengthening (CSS); and Movement-Building – all while the world continued to grapple with how to make sense of and operate in a post-pandemic world.

In 2023, our work spanned from country-level implementation to regional coordination and leadership on a broad range of issues. We continued and built upon APCASO partnership's work and efforts from the previous years on: TB community and civil society mobilisation, advocacy and strengthening; supporting stronger and more effective community and civil society engagement in Global Fund country coordinating mechanisms (CCMs); community-led monitoring (CLM); as well as broader advocacy on and resource for community systems strengthening. Worth to note though, are newly-emerged projects and programmes that have enabled APCASO to work with country partners in responding to the changing global socio-political contexts and issues: we have started work to support effective community engagement in: pandemic governance, influencing the outcomes of the three health U.N. high-level meetings (HLMs), and ensuring community participation and voice in TB drug protocol reviews.

2023 was a year of stepping up on our hosting duties to key regional networks that advance human rights and community engagement work in Asia-Pacific: Activists' Coalition on TB Asia-Pacific (ACTIAP) and People's Vaccine Alliance Asia (PVA Asia). While we ended our hosting of the Global Fund Advocates Network Asia-Pacific and the Global Fund Community, Rights and Gender Platform, we have also taken on new commitments to support, host, and grow the Global Fund-supported Knowledge Hub for Community Engagement and Leadership in Pandemic Governance (CELG) and the Asia-Pacific Community Advisory Board (CAB) of the USAID-supported Supporting, Mobilising, and Accelerating Research for Tuberculosis Elimination (SMART4TB) consortium.

We continued 2023, guided by our ten-year strategic plan and the post-pandemic era, APCASO was able to define the scope of our work while taking into consideration the diversity of our focal points that contribute to our work, as well as the evolving environment of health advocacy in the region. Our 2022-2032 strategic plan gave us room for the organisation to continue to grow and evolve.

Now that developments are happening in both the financing landscape and donor funding in relation to support being given to community organisations, we were able to focus on community systems strengthening, on campaigns and movement building, beyond the technical assistance that we have been doing.

APCASO has been hosting the Asia-Pacific Community, Rights, and Gender (APCRG) Platform since 2015. In this 3rd phase of hosting, we continued to serve as an interface between the Global Fund Secretariat, the global and regional technical partners, and the regional and national level key populations networks, community networks and civil society organisations.

Objectives

1 To enhance community knowledge of the Global Fund and its processes. through the regular bi-directional sharing of tailored and targeted information to a diverse audience

To strengthen the capacity and coordination of communities to engage in national and regional Global Fund grants and related processes

3 To improve community access to technical assistance (TA) through information-sharing, linkage to appropriate providers, support developing requests, and strengthening TA provider capacity and coordination

GOVERNANCE (CELG)







Funder: Global Fund **Period:** June 2023 - March 2024

Background

APCASO, as host of ACT!AP, supports community engagement assessments and plan development in Cambodia, Indonesia. and the Philippines to enhance involvement in TB and PPPR responses. Regionally, APCASO is developing a common engagement tool for use in these three countries and five countries in Africa, Additionally, APCASO maintains a CELG Community of Practice and compiles lessons learned from eight countries.

Objectives

To support the last-mile populations (LMPs) and TB key and vulnerable populations (KVPs) in engaging in the national pandemic prevention, preparedness, and response (PPPR) at country level. This will be achieved by developing and testing community engagement strategies, approaches that enable LMPs as part of the TB networks to influence COVID-19 and PPPR decisions.





APCASO is part of the EANNASO/APCASO/ATAC consortium, a team of pre-qualified community and civil society-led technical assistance providers on CLM to support long-term technical assistance activities in Bangladesh (TB) and the Philippines (TB) as well as short-term technical assistance in Mongolia.

Objectives

- Strengthen integration of CLM into disease responses through improved linkages to national strategies
- 3 Generate evidence on the impact of CLM on service delivery and service access, collaborating with different stakeholders including communities.





Background

Under the Global Fund's Community Engagement Strategic Initiative (CE SI), ACT!AP/APCASO, was provided with a top-up grant to support meaningful engagement of people affected by TB in the country level GC7 processes. This support included regional technical assistance to TB affected communities, codevelopment and dissemination of GC7 resources, sub-grants to TB survivor or key populations (KP) networks, organisations or groups at country level to support pre-consultations and identification of priorities, as well as engagement and follow ups with writing teams, KPs and Civil Society Country Coordinating Mechanism (CCM) representatives and CCM secretariat.

Objectives

To provide support to TB survivor or KP networks, organisations or groups at country level for GC7 TB affected community engagement and consultations on TB affected community networks/associations.



Key Deliverables

- Sub-granting and technical assistance provided to 8 country partners
- TB-affected communities consultations carried out in 8 countries




Key Achievements

The project was instrumental in supporting, in many countries, the first ever community level consultation for TB-affected communities to actively engage in the funding request development for GC7. Communities were also actively involved in national processes and institutions such as being part of developing national strategic plans, supporting civil society participation in their country coordinating mechanisms (CCM), as well as standing as experts in their fields of advocacy on which the national mechanisms could rely upon for knowledge. The inclusion of community priorities in the Annex of Funding Priorities of Civil Society and Communities for GC7 was an important milestone.



Background

The CCM Evolution was a TA provided by APCASO through the Global Fund's CCM Evolution Strategic Initiative. While the initiative had several interventions, APCASO focused on CCM election process support to enhance KP, PLWD, CS, and/or community's CCM election/selection process(es) for meaningful representation and engagement. The CCM Evolution Strategic Initiative was a catalytic opportunity to enhance the way partnership works in countries and regions.

Objectives

- 1 Identify challenges related to representation and engagement of KP and/or PLWDs, CS and communities
- 2 To enhance CS elections/selections through ethical, well-documented and widely published and transparent processes,
 - 3 To improve bi directional feedback mechanisms between the representatives and their constituencies
- 4 To build the capacity of existing KP and/or PLWDs, CS and/or community representatives.



Our technical assistance to 8 CCMs in the region through the election process ensured a transparent, inclusive and independent process that allowed for wider and more representation as well as engagement of key population, PLWD and civil society in the CCMs. This in turn ensured that CCMs are adequately equipped to facilitate inclusive oversight and meaningful engagement of communities in the country grants of their countries.

Background

From 2021-2023, ACT!AP & APCASO, with funding support from the Global Fund, Community Engagement Strategic Initiative (CE SI). Component 2 have been implementing the Long-term capacity strengthening of Community Networks and Organisations of People Affected by Tuberculosis (TB).

Objectives

- 1 Amplify the voices and participation of TB-affected communities in policy and decision-making for a and in the governance and stewardship of the TB response.
- Strengthen the influence of TBaffected communities on the design and implementation of national strategies and costed implementation plans, to reflect and respond to the realities and needs of these groups as they relate to human rights, gender, community responses and community systems strengthening.
- Empower tuberculosis-affected communities to monitor national program coverage and quality, and commitments to end tuberculosis and to utilize the information generated for advocacy and programmatic action.

Key Deliverables

- Establishment and mobilising community TB survivor groups in 5 countries
- Publication and roll-out of a toolkit. 'People Affected by TB Matter, A Playbook on Community Engagement'
- Convening of a regional reflection and learning meeting to share, reflect and learn on best practices, lessons learned and challenges



Key Achievements

The long-term capacity building efforts saw increased engagement of TB-affected communities in GF CCM, active participation in the GC7 processes, involvement in the GC7 grant negotiation-making process, integration of community-centred interventions in NSP and integration of CLM in NSP and GC7 funding request. There was also a substantial increase in capacities of TB-affected communities on GF processes and CRG in TB programming and development of CRG costed action plan.

PROMOTE AND SUPPORT EVIDENCE AND RIGHTS-BASED ADVOCACY IN SOUTH EAST ASIA AND THE PACIFIC ON HARM REDUCTION PROGRAMME





Funder : N/A Period : Sep 2022- Aug 2024

Background

The project aimed to safeguard the rights of vulnerable communities impacted by harsh drug policies in Asia, ensuring that Community-Based Organisations (CBOs) can operate effectively. It prioritized evidence-based and human rights-focused responses to the drug issue, emphasizing community involvement. Core funding supported civil society and CBOs, enabling advocacy, legal aid, community dialogues, COVID-19 support, and more.

Objectives

The policy advocacy activities were done across the project period including the successful meeting with law and justice institutions. The community mobilisation activities were conducted with national and regional stakeholder which also incude the National Conference with Lawyers on Harm reduction and human rights.



Key Deliverables

Funder: Treatment Action Group (TAG) Period: Jun 2023- Sep 2024

Background

This project is a USAID cooperative agreement to accelerate process to achieve the End TB goals in high burden countries. SMART4TB implements research studies with local partners including Community Advisory Boards (CABs) to identify effective people-centered methods for finding, treating, and preventing TB through the strengthening local capacity to conduct high-quality research.

Objectives

Engaging TB-affected community and civil society working on TB in TB research process to ensure alignment with community needs and priorities.



Key Deliverables

- 13 members of Asia Pacific CABs completed pilot online training curriculum
- CABs member engaged in two protocols review related to shortened regimen drug-susceptible TB and program for Rifampicin-resistant disease with stratified medicine TB
- CAB Members participated and presented at the Union Lung Conference in November 2023 at Paris. France.



Key Achievements

APCASO on behalf of the regional CAB leadership for Asia pacific representatives were part of the SMART4TB CAB training curriculum (CAB LAB). The total of 13 members of Asia Pacific CAB have completed and gained more knowledge on TB, project related as well as information on protocol review which enable all the member to concretely participated in the 2-protocol review by the end of 2023.

PEOPLE'S VACCINE ALLIANCE ASIA (PVA ASIA)





Funder: Frontline AIDS through ActionAid Period: 1 Sep 2022 – 30 Sep 2023

Background

This is the second year that APCASO has been implementing the project under People's Vaccine Alliance — Asia. As a key partner and a Steering Committee member in the region, APCASO has not only be developed and rolled out the Community Toolkit that it has developed, but have also hosted the Secretariat from June 2023 until the present.

Objectives

APCASO aimed to develop a High-Level Meeting "Community Toolkit" to support civil society and community partners during the High-Level Meeting on PPPR, the Pandemic Treaty, and the International Health Regulations (IHR). This Toolkit included a "how-to" guide in facilitating consultations at the country level, setting agenda and facilitating advocacy priorities based on the outcomes of the Regional Strategizing Meeting held in March 2023. This also included a number of advocacy briefs that will support the understanding of issues and of the processes such as that of the UN HLM on PPPR.

- Regional civil society and community strategising meeting co-hosted in March 2023 in Jakarta, Indonesia : 1
- Community Toolkit on PPPR developed : 1
- Country rollouts conducted using the Community Toolkit Active PVA Asia Secretariat hosting : 5


Key Achievements

One key achievement this year was taking on the responsibility of hosting of People's Vaccine Alliance — Asia (PVA Asia). This is a challenging undertaking given the changing priorities and the shift away from COVID-19 in the region. As its new Secretariat, APCASO continued to mainstream PVA Asia as part of its core work, aligned with its 2021-2023 Strategy and the new 2024-2026 Regional Strategy that APCASO facilitated among PVA Asia Steering Committee members and partners.

PPPR is relatively new, especially in Asia and Southeast Asia, where responses typically emerged from central government emergency frameworks. In countries like the Philippines, the COVID-19 response structure followed a disaster risk reduction model but lacked civil society engagement. As countries transition from emergency to normalcy, each is figuring out its mechanisms. Civil organisations need to assert their presence and ensure civil society consultation becomes an integral part of pandemic response, not just limited to national governments.

COUNTRY SPOTLIGHT TOWARDS AN INCLUSIVE CLM STRATEGY FOR TB IN MONGOLIA

In late 2022, APCASO undertook a community-led monitoring (CLM) short-term TA assignment in Mongolia under the Global Fund CLM ST. This short-term TA aimed to

- (1) Develop an initial CLM strategy to guide CLM implementation;
- (2) Increase knowledge and understanding among the CCM and MTC about CLM: and
- (3) Support the identification of CLM interventions to be included in Grant Cycle 7 (GC7) Funding Request (FR).



Given that this was an initial engagement and a shortterm TA, we took the opportunity to approach this from a broader, more long-term perspective with longer-term impact to the country, especially in the context of setting up the CLM mechanism in Mongolia.

This TA was coursed through the Mongolian Tuberculosis Coalition (MTC), where APCASO visited Ulaanbaatar from 25 February to 03 March 2023. This first visit included courtesy visits CCM coordinating office; and the conduct of a 3-days workshop that achieved the following outcomes:

- 1. Proposed interventions for inclusion in the Global Fund Funding Request for GC7 were identified, including specific activities, budget line items and schedule of implementation. The key interventions included:
- i) Establishment and operationalization of CLM Working Group; ii) Establishment and strengthening TB network of TB survivors and affected community; iii) Data collection and analysis; iv) Advocacy; and v) Monitoring, evaluation and documentation; and

2. A Proposed CLM Strategy for TB in Mongolia, proposed CLM interventions, TB epidemiology and preliminary findings of the desk review

These outcomes set the ground for the extent of additional work that needed to be implemented in the country, and enabled the need to implement succeeding short-term TA. Following up our first phase, we requested and, upon the agreement with the Global Fund, provided support through a second phase to finalise the CLM Strategy and to take initial steps to support the establishment of the CLM Coordinating Committee (CCC). The establishment of the CCC would be initiated by the CLM Task Force (TF) that was established through the workshop that APCASO facilitated during the second visit. This TF was community-led and included seven TB survivor individuals and members of TB civil society.

Apart from the formation of the TF, two other major progresses were:

- (1) Agreed in-principle steps to support the adoption of the CLM Strategy
- (2) Reached in-principle agreement on initial steps to support establishment of the CLM Coordinating Committee



TB-affected community and survivors who participated in the 2nd workshop also agreed to compose a Mongolian translation of the terminology, 'community-led monitoring', which is now ONUKh or OHYX, which is a literal translation of CLM. Additional support for the proper implementation and operationalization of the CLM Task Force was necessary for the TF to continue, given how CLM as a mechanism in TB is new in the country. Thus, APCASO and MTC committed to provide financial and logistic support to make sure that the CLM TF will be able to operate effectively based on their workplan.

MTC and APCASO felt the need to sustain the momentum and fully support the establishment of the CCC by agreeing on its structure and terms of reference (ToR), as well as finalising the CLM Strategy and the CLM Indicator Framework. Together with the request from MTC, APCASO proposed for a third short-term TA in Mongolia.



APCASO visited the country again in September 2023 wherein we took the opportunity to align with one of our ongoing capacity-building activities under the Global Fund TB Community Engagement Strategic Initiative (CE SI). This 3rd short-term TA strengthened the awareness of the initial CCC members on CLM; informed CCC members of the CLM Strategy and CLM Indicator Framework; and agreed on the structure and terms of the CCC.

Towards the end of this meeting, MTC was appointed as the Secretariat of the CCC and to reach out individually to prospective CCC members and formally confirm their membership. As the Secretariat, MTC also confirmed to steer the CCC and ensure the adoption of the CLM Strategy on TB.

It may seem as small contributions to Mongolia and to the TB-affected communities and civil society working in TB in the country, but this series of short-term TA was received with much appreciation from our country partners considering the high TB burden and the lack of a coordinated TB community-led response and CLM in the country.

Two key outcomes transpired during this series of support: internally, Mongolia now has a functional, coordinated network of TB community of survivors and affected individuals, as well as civil society working on TB that can implement national-level interventions such as CLM. Externally, this series of support has increased the attention and focus of technical partners and funders, such as the Global Fund, towards Mongolia as a high TB-burden country, and facilitated the inclusion of Mongolia as one of the country partners under the CE SI TB grant for the period of 2024-2026 to establish and capacitate a TB network in the country.

I am a part of a small TB community, but I realized that this work with APCASO that I can lead and help a bigger community.

Key APCASO & Partner Convenings in 2023




The meeting aimed to disseminate crucial information, highlight developments, address concerns, and identify opportunities for innovation regarding TB, the development of a regional position statement, and other pertinent topics. Furthermore, during the event, we engaged in discussions about country-level plans for mobilisation and advocacy, as well as identified areas requiring support. This convening attracted over 80 representatives from regional and national civil society organisations, as well as community-led organisations focused on TB, UHC, and PPPR. Additionally, government representatives from the region were also in attendance.


- stronger and explicit commitments from governments in the region to people-centred, equitable, gender transformative, and rights-affirmative UHC, pandemic, and TB approaches and responses, and reflected in the outcome documents of the three HLMs:
- stronger capacity of Asia-Pacific community and civil society networks to engage in and influence HLMs; and
- a model from the region of meaningful community- and civil society engagement and collaboration with governments, development partners and technical agencies.

APCASO convened a roundtable dialogue to call for leadership toward people-centered, equitable, gender-just and rights-affirmative 2023 HLMs on UHC, PPPR, and TB. It was participated by key organisations from Thailand, both from NGO and government sides and APCASO focal point countries, Cambodia, Indonesia, Japan, Lao PDR., Mongolia, Pakistan, Nepal, Philippines, and Vietnam along with their government representatives. The participants showed a strong commitment together as a region to engage and collaborate towards better engagement in the HLM both regional and the global levels.



APCASO and partners took part in the UN High-Level Meeting on Universal Health Coverage (UHC), Pandemic Prevention, Preparedness and Response (PPPR) and Tuberculosis (TB) held in New York. Our mobilisation and participation ensured stronger and explicit commitments from governments in the region to people-centred. equitable, gender transformative, and rightsaffirmative UHC, pandemic, and TB approaches and responses, and reflected in the outcome documents of the three HLMs and more importantly showed the capacity of Asia-Pacific community and civil society networks to convene. engage in and influence the HLMs. We also 20th-22nd convened a side-event: The Asia-Pacific **SEPTEMBER** (AP)Rising: A Region Reaffirming and Standing UNHLM New York, USA Together for People-centred, Equitable, Genderjust, and Rights-affirmative 2023 High-level Meetings (HLMs).







PVA Asia members and project partners gathered to review the alliance's achievements in 2023, discuss strategies for the same year, and plan revisions for the period of 2024-2026. ActionAid Nepal organised this event, facilitated by the PVA Asia secretariat from APCASO. Attendees included GCAP, Oxfam India, IAC, CPRH, ActionAid India, SAAPE, and APN Plus. Additionally, on the second day, gap analysis and problem-setting sessions were conducted to develop medium-term and long-term goals spanning 2024-2026.

APCASO representatives and partners from various projects and countries from Asia and the Pacific participated at the World Conference on Lung Health in Paris, France. The conference focused on the presentation of the latest information and research on lung health, transforming evidence into practice. The conference also provided space for community organisation to promote and present their work to a wider stakeholders including participants from research institutes and pharmaceutical sectors who participated in the event. APCASO also had an opportunity to share the community issues in the fight against TB at the roundtable side-event discussion.



As APCASO concludes its nine-year hosting of the Asia-Pacific Community, Rights, and Gender (APCRG) Platform, it held its final gathering of country partners, technical assistance providers, and technical partners in December as part of the BIG BANGkok Meeting 2023. Titled "Transitions", the meeting aimed to share insights on how the APCRG Platform, and as it transitions to the Asia-Pacific Learning Hub under a new host, support civil society and community partners in Grant Cycle (GC7) grant implementation and oversight. Almost 60 participants from 14 countries as well as regional participated in one meeting.









The Activists' Coalition on TB – Asia-Pacific (ACT!AP) held its one-day annual general assembly as part of APCASO's BIG BANGkok Meeting in December 2023. This assembly was crucial as ACT!AP transitions into a new set of Steering Committee members who will steer and supervise the workings of the regional coalition. The meeting discussed and agreed the process for the selection of the new set of Steering Committee members through the Selection Committee that was formed during the meeting; and shared successes in 2023 as well as prospects for 2024. Around 25 ACT!AP members from 9 countries attended the general assembly.

APCASO and ACT!AP convened a regional reflection and learning meeting for CE SI TB partners to share, reflect and learn best practices, faced in strengthening capacities of TB-affected communities to be able to engage effectively in the national TB response decisionmaking spaces and Global Fund related processes. Project partners from Cambodia. Indonesia, India, Mongolia, Nepal, Sri Lanka, Pakistan, PNG and Vietnam took part in the meeting. We also had the opportunity to launch two new publications during the meeting; 'The Power of Community, Engaging the Global Fund Grant Cycle 7', to capture the case studies of the 8 countries that received sub-grant and technical assistance for effective engagement of TB-affected communities in the GC7 processes and a toolkit. 'People Affected by TB Matter. A Playbook on Community Engagement' for country partners to utilize to further strengthen and mobilise the TB movement in countries.



Internal Events and Meetings in 2023

CoR Meeting, Jakarta, Indonesia

APCASO took the opportunity of the majority of its Council of Representatives (CoR) members being in an organisational convening in Jakarta, to hold a check-in meeting with programme staff. The staff team, led by the Executive Director, shared key programmatic and financial organisational updates with the CoR for their information and advice. The staff team also reported on progress on APCASO organisational effectiveness workstreams: monitoring, evaluation and learning (MEL); communications; focal point (FP) engagement; and resource mobilisaton including on emerging new thematic areas of work.

In this year's meeting of the Board of Directors, the Executive Director provided key updates about progress of APCASO work as well as an overview of our financial status and staffing situation, for the Board's information. Key agenda items deliberated and approved via Board resolutions at this year's meeting are:

- The Y2022 Audit Financial report
- The re-confirmation of the Y2023 Annual Operating Budget (AOB) and approval of the indicative Y2024 AOB
- Board membership changes
- Policy setting of organisational external consultant rate and revision of APCASO per diem rate for incorporation/amendment in APCASO's Operations Manual

3rd AUGUSTBoard Meeting, Bangkok, Thailand
